




Expanding research investments to include all rigorous causal research, including RCTs and QEDs


Diversifying the community of researchers and supporting early-career researchers

Selection Criteria



Study Design

- Clear treatment and counterfactual/control group
- Data, sample size, timeline
- Identification strategy rationale and proposed sensitivity analyses

Program Implementation

- External programmatic funding
- Prospective studies: Program implemented under real-world conditions

Policy Relevance

- Domestic policy or program
- Policy levers to support scaling if effective
- Potential to inform policy at local/state/federal level

We will prioritize studies with...



- Policy-relevant primary outcomes
- Short- and longer-term outcomes
- Administrative data
- Researchers have not previously received AV funding
- Building Evidence RFP (QED): Potential pathway to more rigorous future evaluation (an RCT or additional QED)
- Strengthening Evidence RFP (RCT): Previous evaluations (RCTs or QEDs) suggest positive impacts

Ready to Apply?



Stage 1 - LOI submission

- Building Evidence (QEDs): June 1 deadline
- Strengthening Evidence (RCTs): Rolling submissions

Stage 2 – Invitation for full proposal and project budget

- Building Evidence: Notified by July 15
- Strengthening Evidence: Reviews completed within 4-6 weeks of submission

Building Evidence RFP

Arnold Ventures' Evidence and Evaluation team aims to identify, evaluate, and scale evidence-based solutions targeting the nation's most pressing social problems. This funding targets the first two phases of that goal – identifying and evaluating potential solutions – and is geared toward studies examining the causal effects of a policy, program, or intervention that aligns with key AV policy areas. Causal research employing strong, quasi-experimental methods are a critical component of the evidence-building process and are important for increasing the knowledge base for decision-makers and stakeholders. Examples of causal research methods include natural experiments, regression discontinuity, difference-in-differences, and instrumental variable designs.

Under this Request for Proposals (RFP), we are seeking studies that will advance the knowledge base within key AV policy areas, including higher education, infrastructure, contraceptive choice and access, and public finance.
